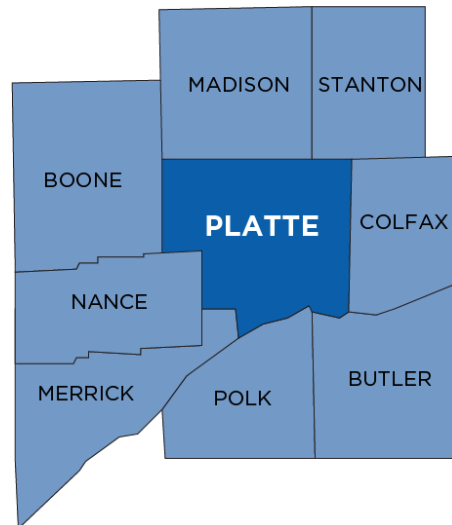

ECONOMIC AND DEMOGRAPHIC TRENDS IN **Platte County** AND THE SURROUNDING AREA



This study provides data on labor force, employment, commuting patterns, population, migration, retail sales, and income for Platte County. For select measures, comparable data are provided for the surrounding area (selected counties and communities). The map featured above shows the general area for which selected comparable data are shown. In addition to Platte County, other counties included in this area are Boone, Butler, Colfax, Madison, Merrick, Nance, Polk and Stanton. The retail sales section also compares retail growth between Columbus and eight other similarly sized Nebraska communities.

LABOR FORCE AND EMPLOYMENT

Table 1 and Chart 1 (next page) present nonfarm wage and salary data for Platte County for the period 2013–2023. Nonfarm employment is broken down into 11 sectors as defined by the Bureau of Labor Statistics and which are compliant with the North American Industrial Classification System (NAICS).

Nonfarm wage and salary employment consists of the following 11 sectors:

- Natural Resources & Mining
- Construction
- Manufacturing
- Trade, Transportation & Utilities
- Information
- Financial Activities
- Professional & Business Services
- Education & Health Services
- Leisure & Hospitality
- Other Services (except Public)
- Government

The measure of employment reported in Table 1 is data on the number of people employed in the Nonfarm Wage and Salary (W&S) sector in Platte County (regardless of their county of residence). These data indicate total nonfarm wage and salary employment in Platte County increased 4.7 percent (890 jobs) between 2013 and 2023.

Table 1 and Chart 1 also provide employment data for Platte County by major economic sector for years 2013–2023. The Natural Resources & Mining sector recorded the largest percentage increase in employment between 2013 and 2023 (32.5 percent or 157 jobs). The Manufacturing sector recorded the largest actual employment increase between 2013 and 2023 (771 jobs or 14.0 percent).

 Platte County, Nebraska

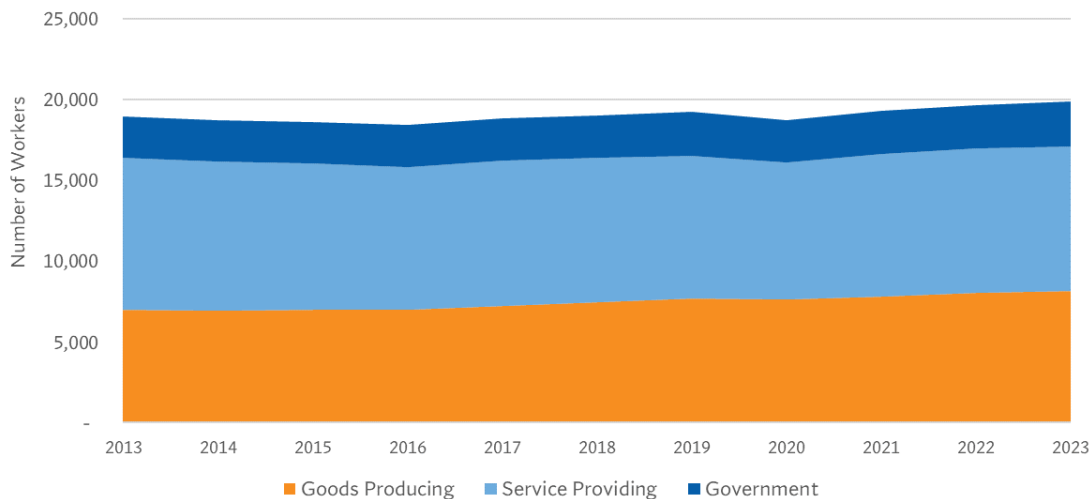


Chart 2 compares total nonfarm wage and salary employment growth in Platte County with metropolitan, non-metropolitan and Nebraska as a whole for the review period 2013–2023. Non-metropolitan Nebraska is defined as Nebraska minus the seven Lincoln and Omaha metropolitan counties of Cass, Douglas, Lancaster, Sarpy, Saunders, Seward and Washington.

As this chart indicates, total nonfarm wage and salary employment in Platte County increased 4.7 percent (890 jobs) from 2013 to 2023, compared to an 8.1 percent increase for Nebraska as a whole, an 8.7 percent increase in metropolitan Nebraska and a 19.6 percent increase in non-metropolitan Nebraska.

Platte County, Nebraska, Metro and Non-Metro Nebraska

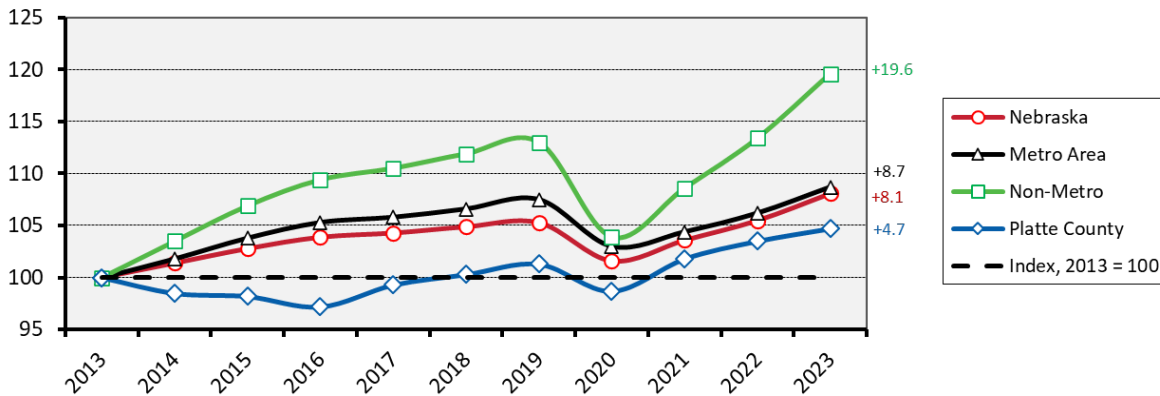
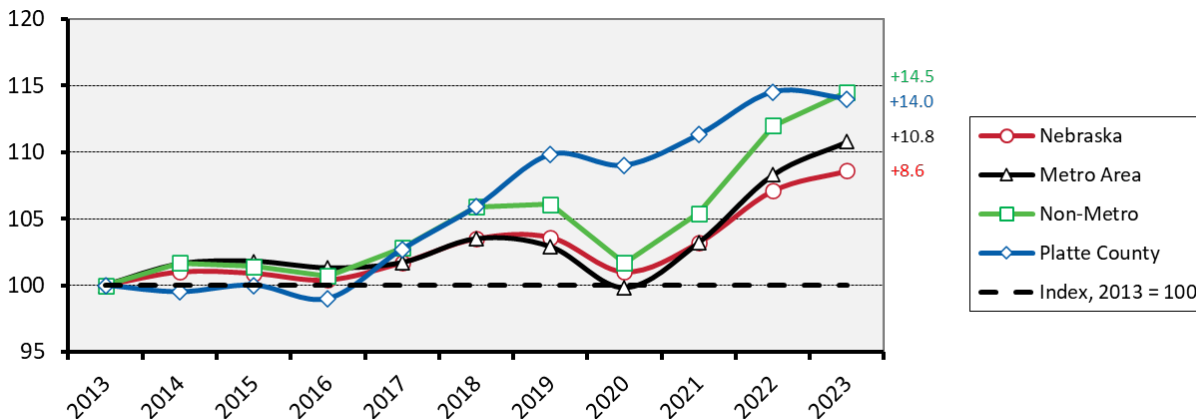


Chart 3 presents data on manufacturing wage and salary employment growth for Platte County, Nebraska, metropolitan and non-metropolitan areas. The Manufacturing sector for Platte County recorded a 14.0 percent increase in employment (771 jobs) between 2013 and 2023. This compares to a 14.5 percent increase in employment for non-metropolitan Nebraska; a 8.6 percent increase for Nebraska as a whole; and a 10.8 percent increase for metropolitan Nebraska over the same period.

The next series of charts (Charts 4, 5 and 6) displays the distribution of nonfarm wage and salary (W&S) employment by major economic sector in Platte County compared to the non-metropolitan and metropolitan distributions.

When comparing the Platte County employment sectors to non-metropolitan Nebraska, the largest deviation occurs in the Manufacturing sector, which makes up 31.7 percent of the county workforce (6,288 employees) compared to 14.2 percent for non-metropolitan Nebraska; a difference of 17.5 percent. Comparing Platte County to the overall metropolitan distribution, the largest deviation is found in the Manufacturing sector (31.7 percent Platte County vs. 6.8 percent metropolitan Nebraska; a difference of 24.9 percent).

The next table (Table 2) shows labor force information for Platte County for the time period 2013–2023. Labor force data (labor force, unemployment, and total employment) are measured based on the county of residence of the labor force participants (regardless of where they work). As the labor force and total employment data indicate, there was an increase in the number of Platte County residents participating in the labor force between 2013 and 2023 (3.9 percent or 688 people).

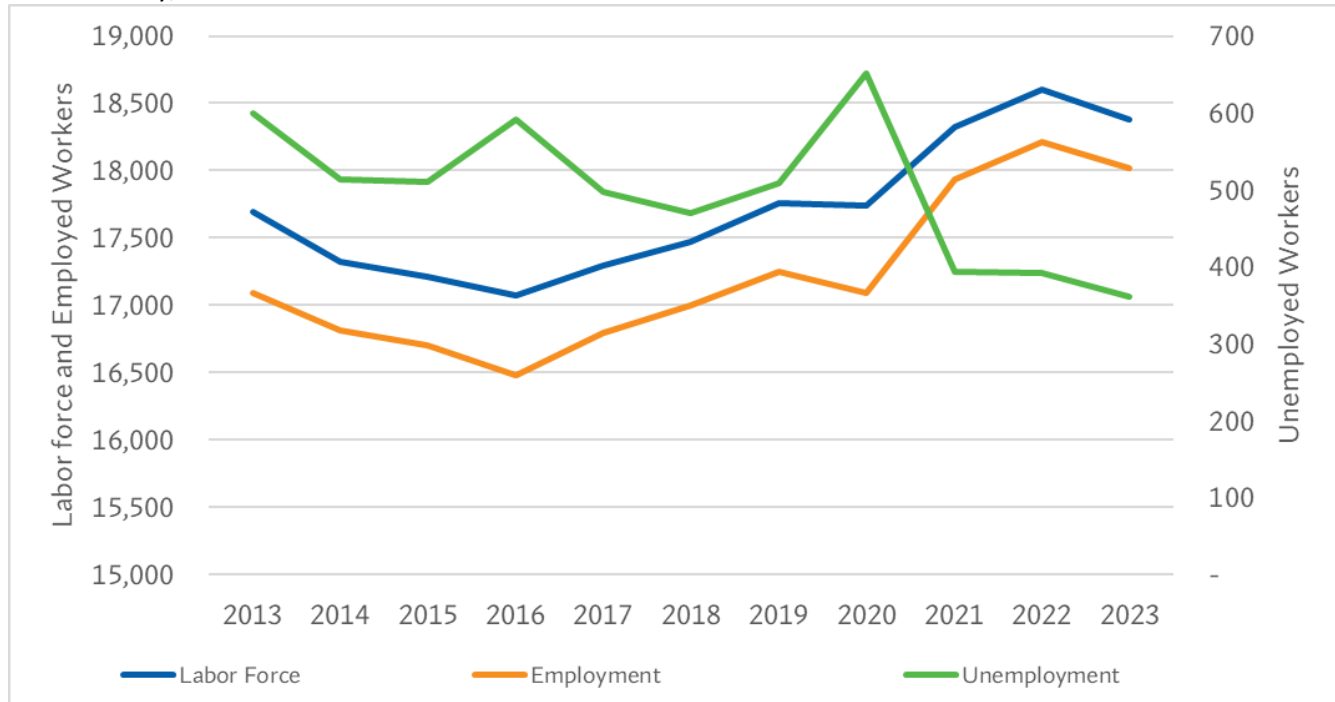
The number of unemployed in Platte County decreased by 39.8 percent (239 people) between 2013 and 2023. Persons are classified as unemployed if they do not have a job, have actively looked for work in the prior four weeks, and are currently available for work. The Platte County unemployment rate was 2.0 percent in 2023; below that for metropolitan Nebraska (2.3 percent), below Nebraska as a whole (2.3 percent), and below non-metropolitan Nebraska (2.2 percent).

RESIDENCE AND WORK FLOW PATTERNS

The next series of tables show residence (Work Destination) and workflow (Home Destination) patterns for Platte County. A Work Destination report looks at where residents in a selected area are working (where they are commuting to work). A Home Destination Report looks at the area from which a county is pulling employees to fill positions. These data are estimates from the U.S. Census Bureau's Longitudinal Employer-Household Dynamics (LEHD) program. This program uses a variety of statistical and computing techniques to combine federal and state administrative data on employers and employees with core Census Bureau censuses and surveys while protecting the confidentiality of people and firms that provide the data. The most current data available for Platte County are from 2021.

Table 3 (pages 6–7) examines the Work Destination area for Platte County from three perspectives: by state, by county, and by place (city). In Table 3, the Census identified 16,592 county labor force participants holding primary jobs. As Table 3 shows, 97.1 percent of Platte County's labor force participants are employed within the state of Nebraska. Approximately 63.3 percent of Platte County workers remain within Platte County for employment with 36.7 percent leaving the county borders for work (next page). The top ten incorporated places where Platte County labor force participants are employed are also shown on the following page.

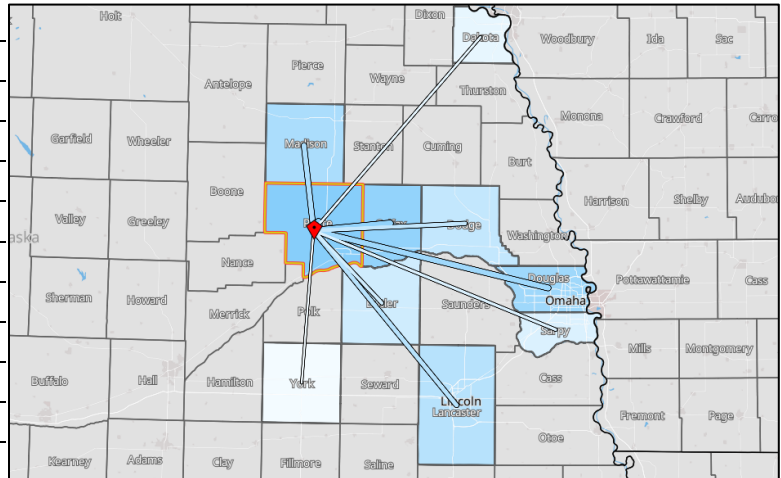

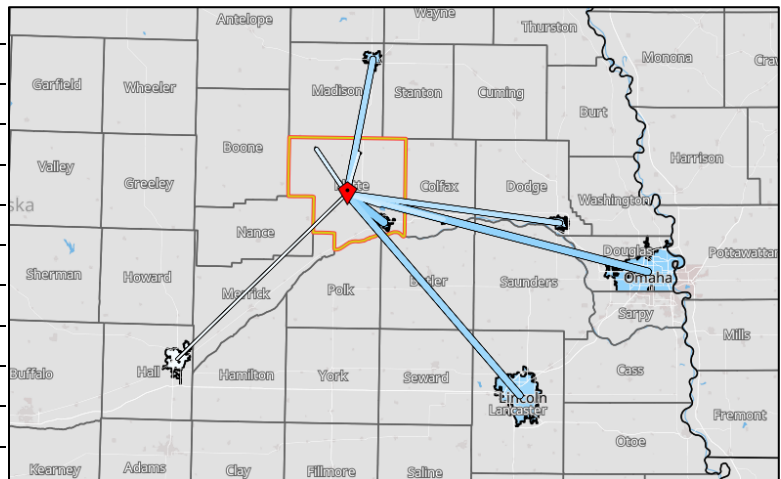

People also travel from other locations to work in Platte County—this is the Home Destination Report or the labor shed area. Table 4 (pages 8–9) depicts the home locations of those employed within Platte County. The Census identified 18,288 primary jobs within Platte County. As Table 4 indicates, Nebraska residents hold 98.0 percent of these jobs. Approximately 57.4 percent of Platte County workers live within the county borders, and the top localities show the distribution of employee residents around the area (next page).

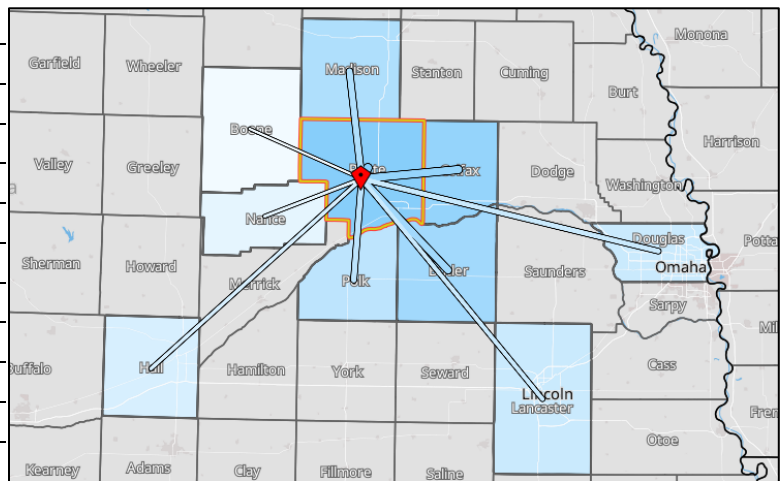

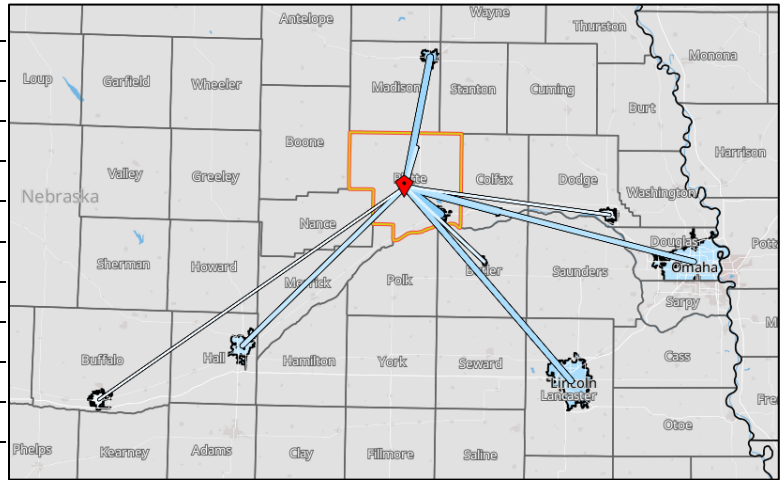

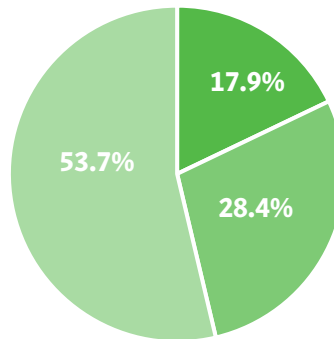

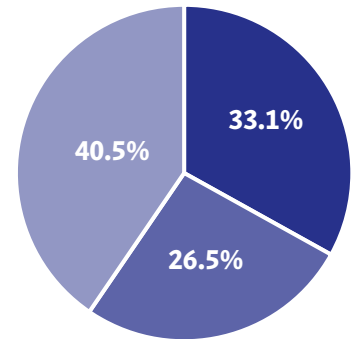

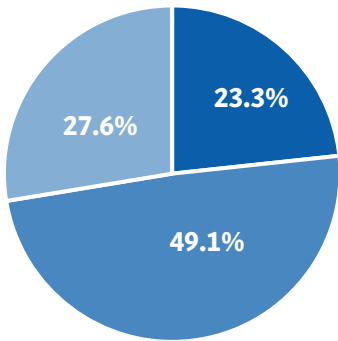

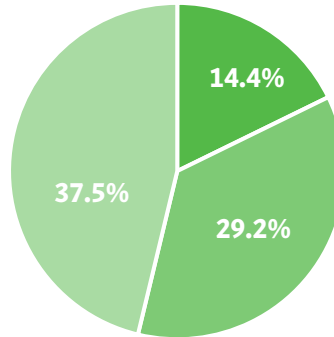

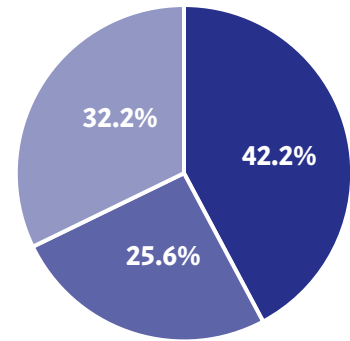

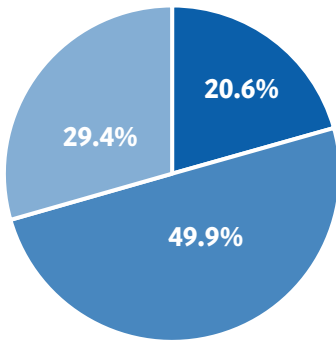

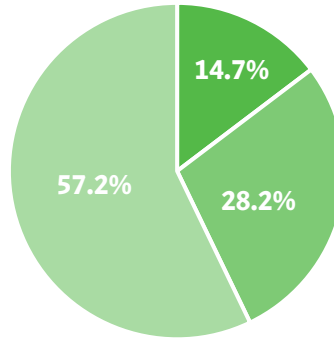

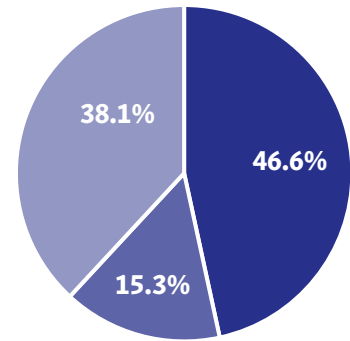

The Distance/Direction Report depicted in Table 9 and Figure 1 shows the number (count) and percentage (share) of primary job holders living in Platte County and the distance they travel to work. Looking at Table 9, the count of primary job holders living within Platte County is greater in 2021 compared to 2019. The distribution of miles traveled to work has shifted slightly since 2019, with workers traveling slightly longer distances. Figure 1 shows the location and concentration of these workplaces.

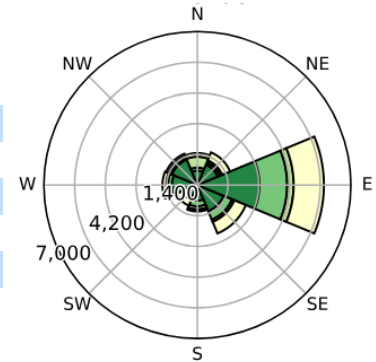


Table 10 and Figure 2 show the number (count) and percentage (share) of people employed within Platte County and the distance to their homes. Looking at Table 10, the number of primary jobs held within Platte County has increased since 2019. The data also show the majority of Platte County employees continue to travel less than 10 miles from work to home. Figure 2 shows the concentration of job counts by distance and direction.

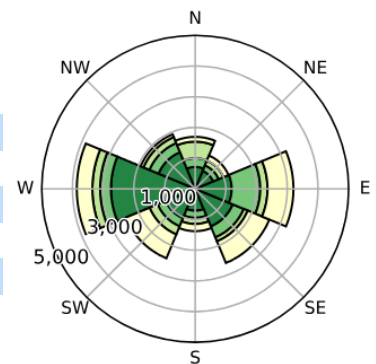

POPULATION AND MIGRATION TRENDS

The following tables (Tables 11 and 12) present population trend data for Platte County and the surrounding area. As Table 11 indicates, Platte County's population experienced an average annual increase of 0.5 percent between 1970 and 2010 for a total increase of 21.4 percent or 5,693 people. This population increase compares to an average annual increase of 0.5 percent, 23.0 percent total, for Nebraska as a whole. Platte County reported an average annual increase of 0.5 percent in population from 2000 to 2023 (7.4% percent or 2,372 people total). This compares to an average annual increase of 0.5 percent, 8.3 total, for Nebraska as a whole during the same period.

Table 12 data reveals the population of Platte County's incorporated places as a whole experienced an average annual population increase of 0.8 percent from 1970 to 2010 and an average annual increase of 0.7 percent from 2010 to 2023 for a total increase of 36.3 percent (6,493 people) from 1970 to 2023. Columbus, the county's largest city, reported a 58.1 percent increase in population (8,993 people) between 1970 and 2023. The unincorporated areas outside of the selected communities experienced a 10.5 percent decrease (905 people) during the period 1970–2023.

The next table and chart (Tables 13 and Chart 17, next page) provide detail on migration patterns. Data reported in these tables are 2018-2022, five-year estimates, which are the latest multiyear estimates available. Multiyear estimates from the American Community Survey are "period" estimates that represent data collected over a period of time (as opposed to "point-in-time" estimates, such as the decennial census, that approximate the characteristics of an area on a specific date). Migration patterns are influenced by employment opportunities, cost-of-living and quality-of-life.

Table 13 shows that the current population, one year or older, is 128 less than the number of people living in Platte County one year ago. This indicates Platte County experienced a net decrease in its population age one and older and in-migration was less than out-migration plus the number of deaths.

The 2018-2022 five-year estimates in Chart 17 reveal a net loss of 280 people from other Nebraska counties and a net gain of 128 people from other states for a total net loss of 152 people one year or older. As shown in Chart 17, net gains occurred in the age groups Age 25 to 44 (gain of 65), Age 65 and over (gain of 8), and net losses in age groups Age 1 to 17 (loss of 2), Age 18 to 24 (loss of 34), Age 45 to 64, (loss of 189).

Chart 17 also shows the net gains and losses by educational attainment for persons ages 25 and older. There was a gain in residents with a HS diploma or less (gain of 184), and a loss of residents with a bachelor's degree, associate's degree, or some college (loss of 233), and graduate or professional degree (loss of 67).

The following chart and table (Chart 18; Table 14) compare the U.S. Census Bureau's age distribution of population for Nebraska as a whole and Platte County. The population of Platte County is slightly older than Nebraska as a whole. The median age for Platte County residents in 2023 was 38.3 years of age compared to 37.4 years of age for residents of Nebraska as a whole.

 Platte County and Nebraska

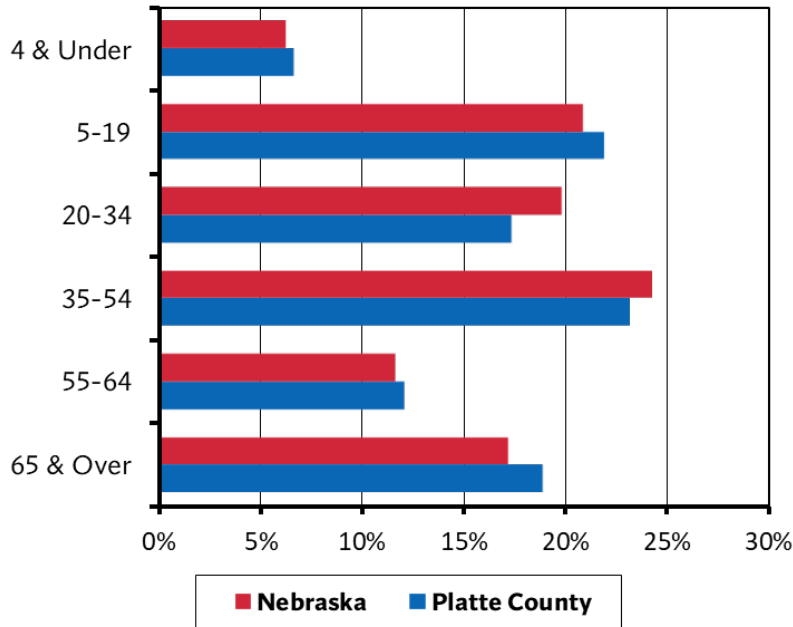

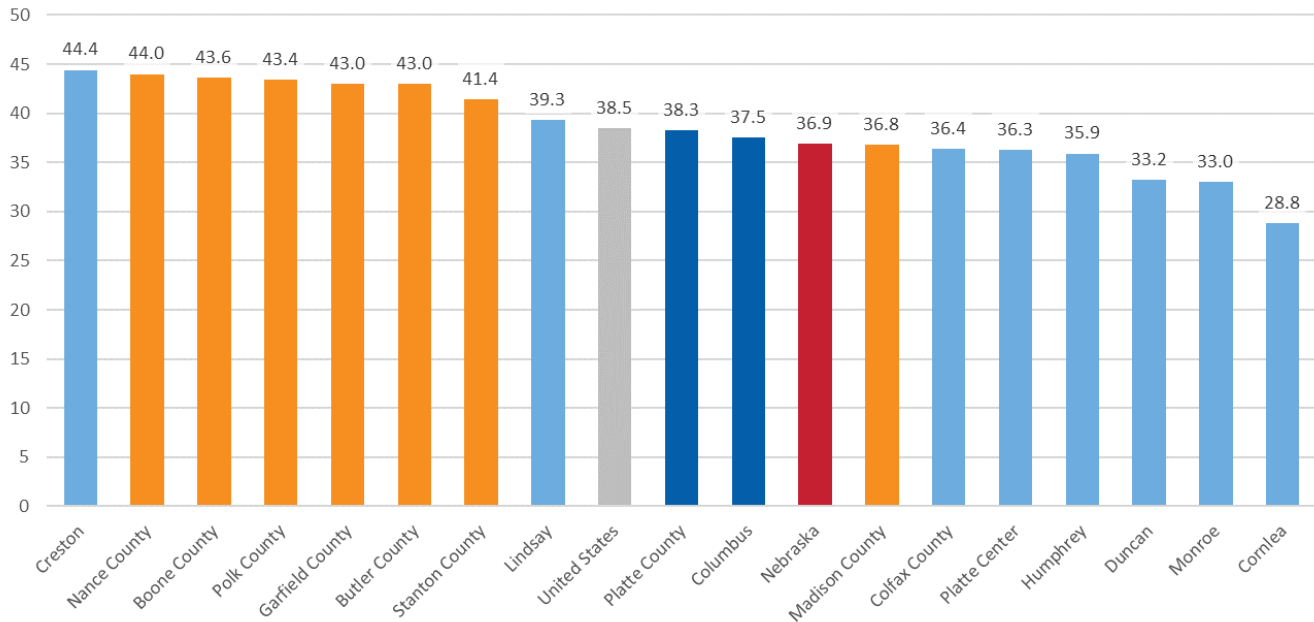

RETAIL SALES

Table 16 and Chart 20 show the retail sales (non-motor vehicle) pull factors for Platte County and the surrounding area for 2023. The pull factor is computed by dividing the per capita taxable, non-motor vehicle (NMV) retail sales by the state average per capita NMV retail sales. A pull factor of one indicates an area has per capita NMV retail sales equal to the state. A value greater than one indicates an area is drawing retail sales from other areas. Conversely, a pull factor with a value less than one indicates the subject area is losing potential retail activity to other places or, in other words, is experiencing retail sales leakage. This simple calculation does not factor in income levels or purchasing power within an area.

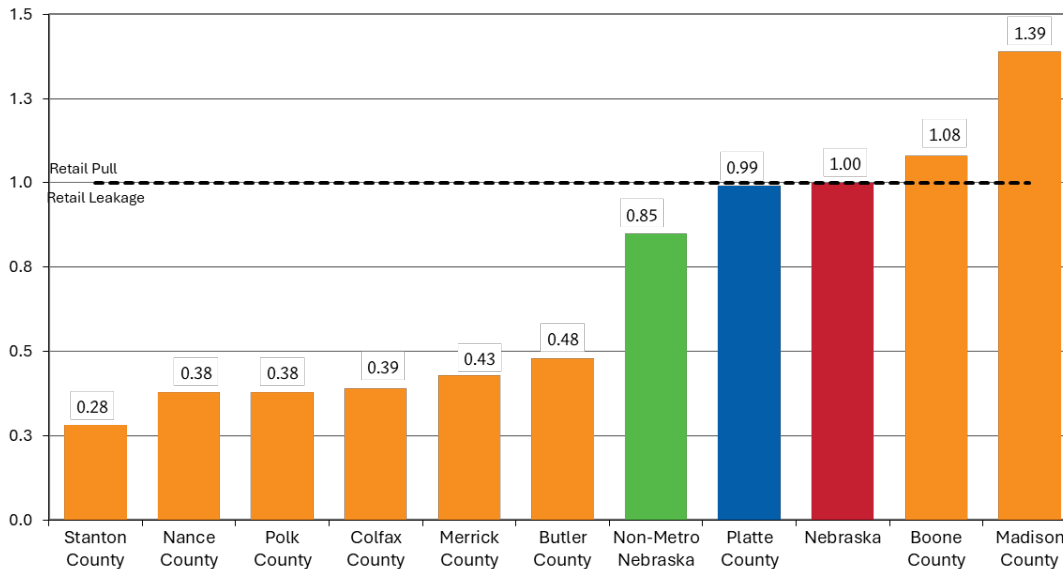

Reviewing the pull factors at the county level indicates Platte County experiences net retail leakages. The 2023 pull factor of 0.99 indicates, on a per capita basis, retail sales in Platte County are less than the state's average per capita sales. Distance from other large trade centers plays a major role in this phenomenon. The comparison of the pull factor for Platte County (0.99) with the pull factor for the non-metropolitan area of Nebraska (0.85) indicates per capita retail sales in Platte County are 16.6 percent above the average per capita retail sales in the non-metropolitan area of Nebraska.

Table 17 and Chart 21 compare the 2023 pull factors for selected area communities. The Platte County community of Columbus's pull factor of 1.00 indicates that, on a per capita basis, non-motor vehicle retail sales in Columbus are approximately 32.8 percent less than the state's average per capita sales.

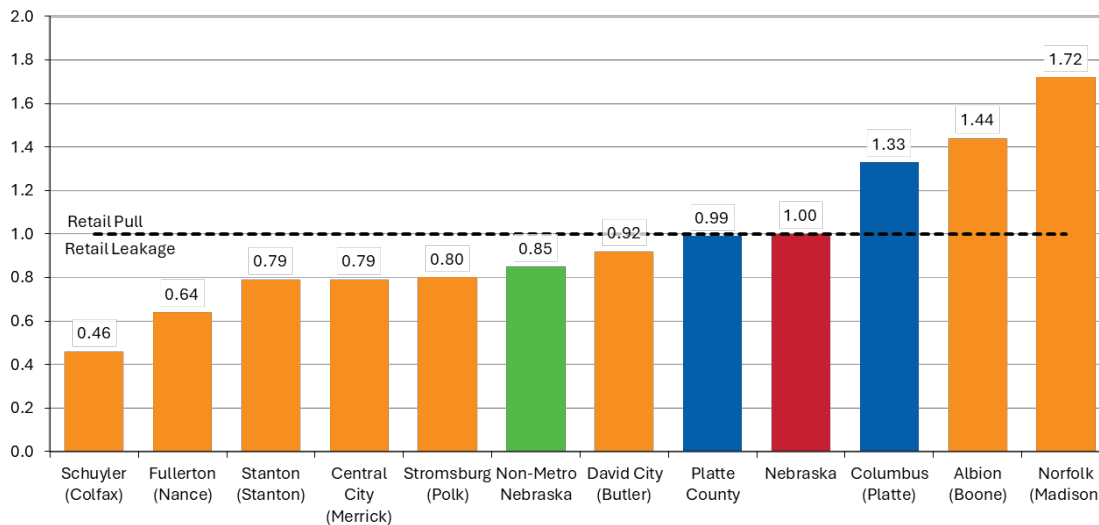

Table 18 (sorted by population) and Chart 22 (sorted by pull factor) further break down the 2023 pull factors into the communities reporting retail sales figures within Platte County. As this table indicates, the community of Columbus had the strongest pull factor (1.00) compared to the other communities reporting in the county. Together, these communities contributed to an overall pull factor of 0.99 for Platte County in 2023.

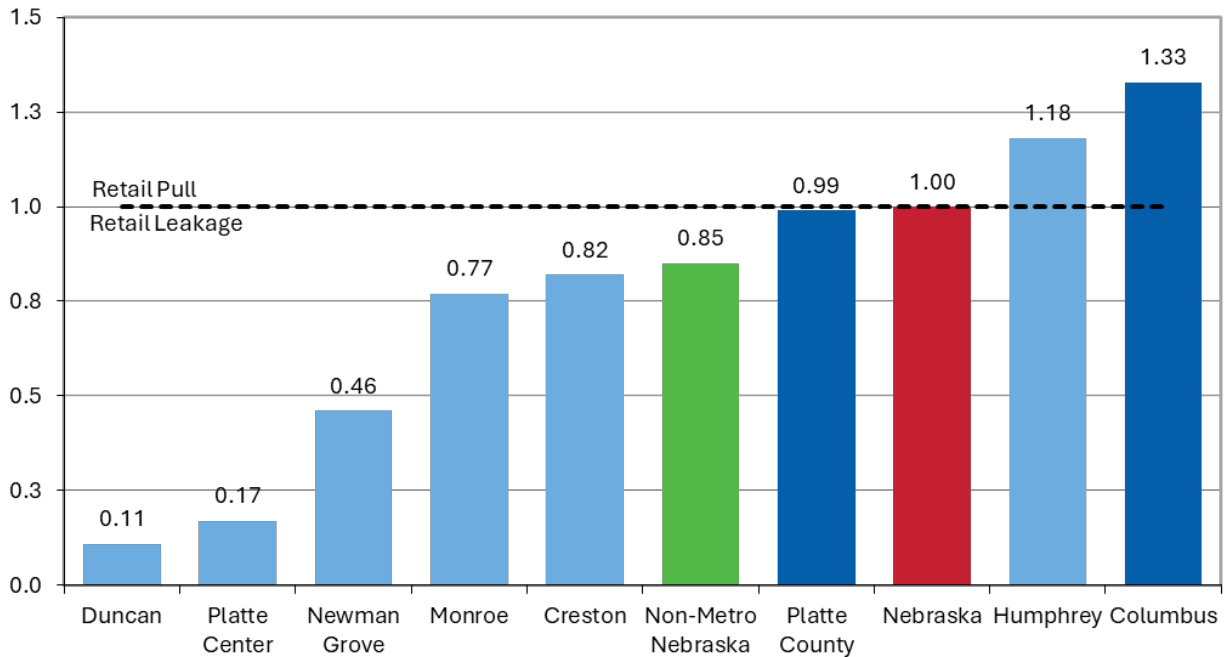

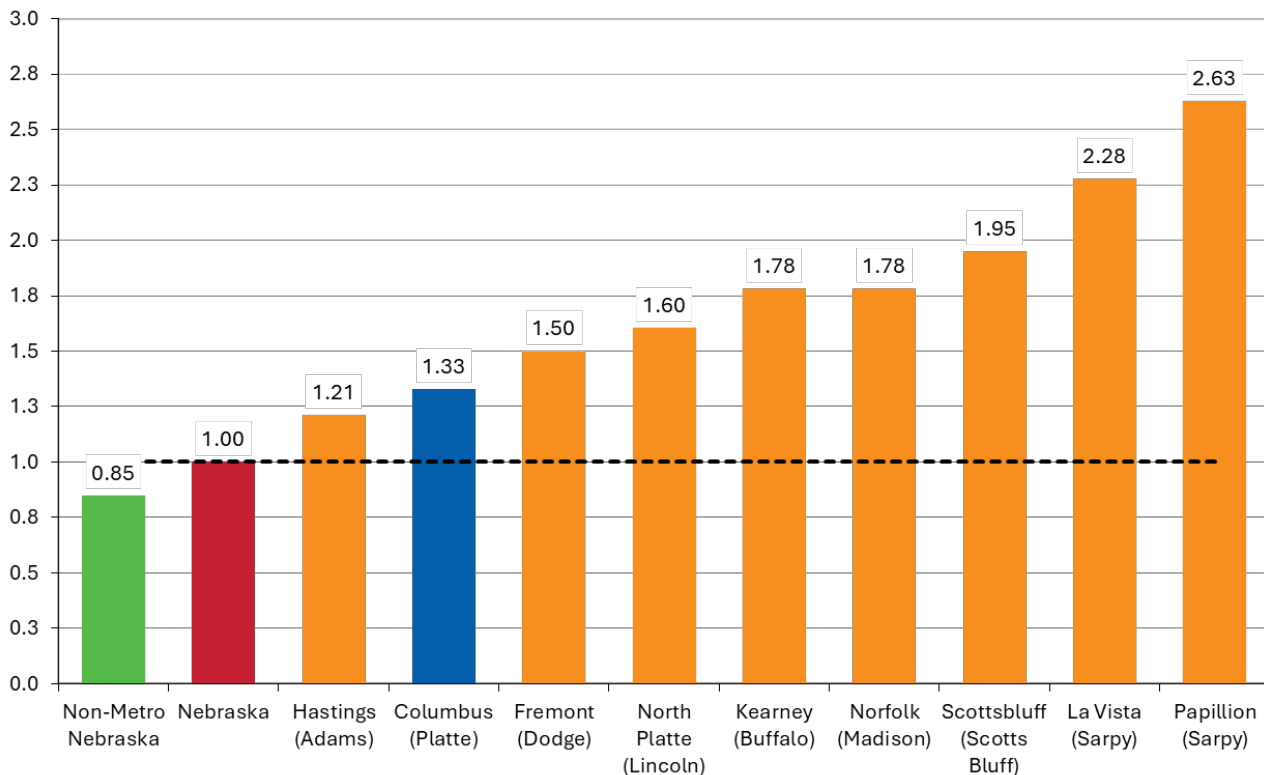

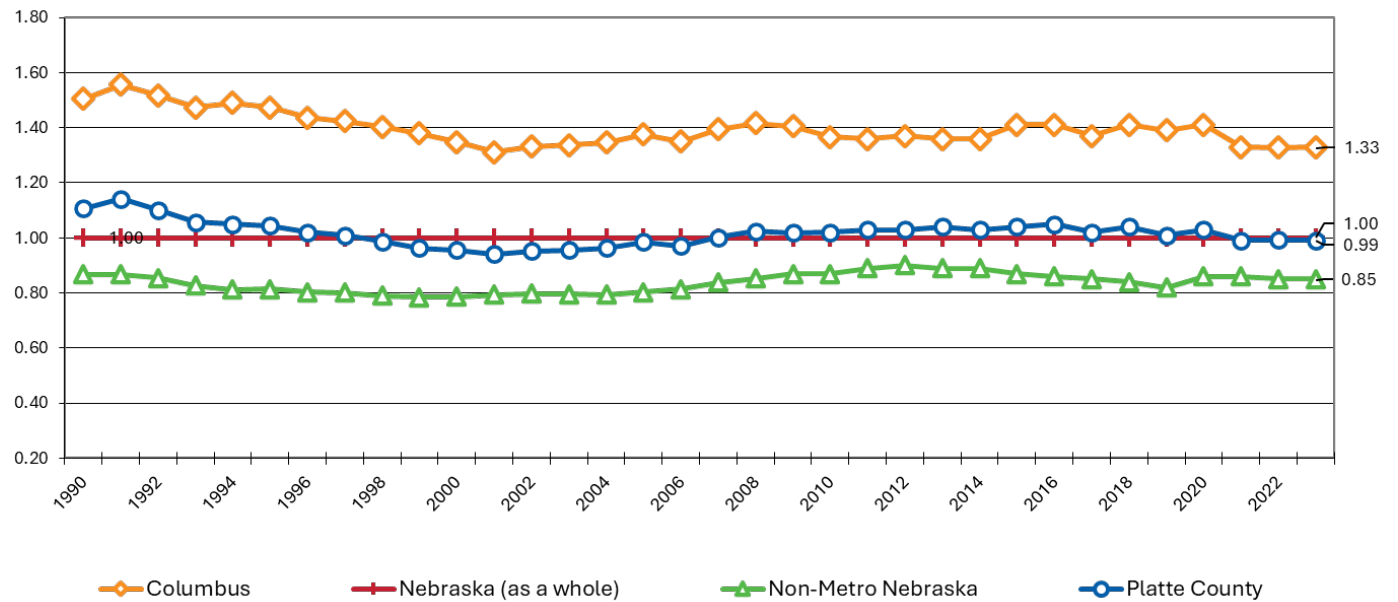

PER CAPITA PERSONAL INCOME

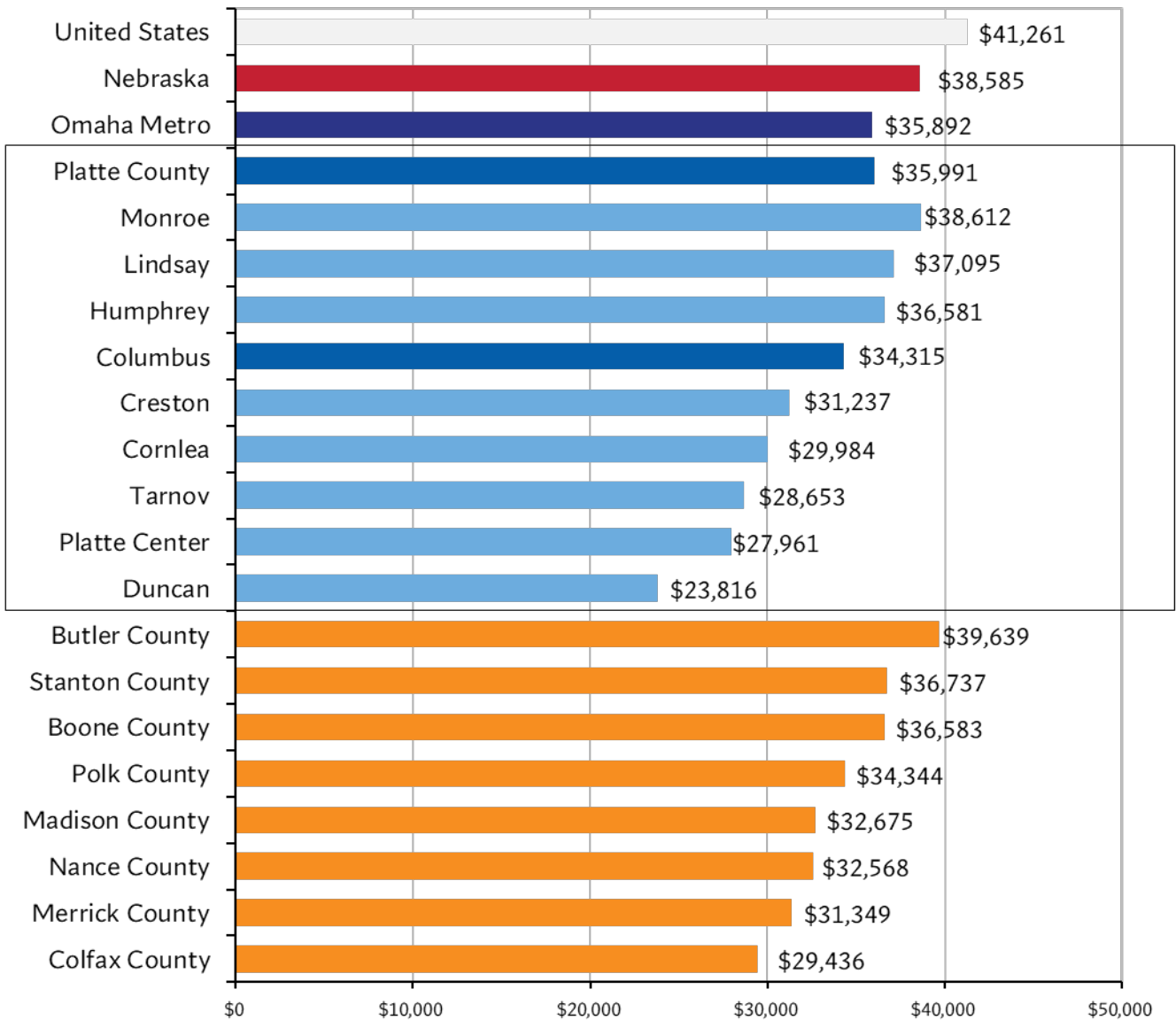
Chart 27 examines the per capita personal income levels within the study area. The American Community Survey data allows us to look more closely at non-metropolitan areas in Nebraska. Information on income distribution comes from various sources, including earnings, retirement income, and public assistance.

The 2018-2022 five-year estimates show that per capita personal income for Platte County is estimated to be \$35,991 compared to \$38,585 for Nebraska as a whole.

MEDIAN HOUSEHOLD INCOME

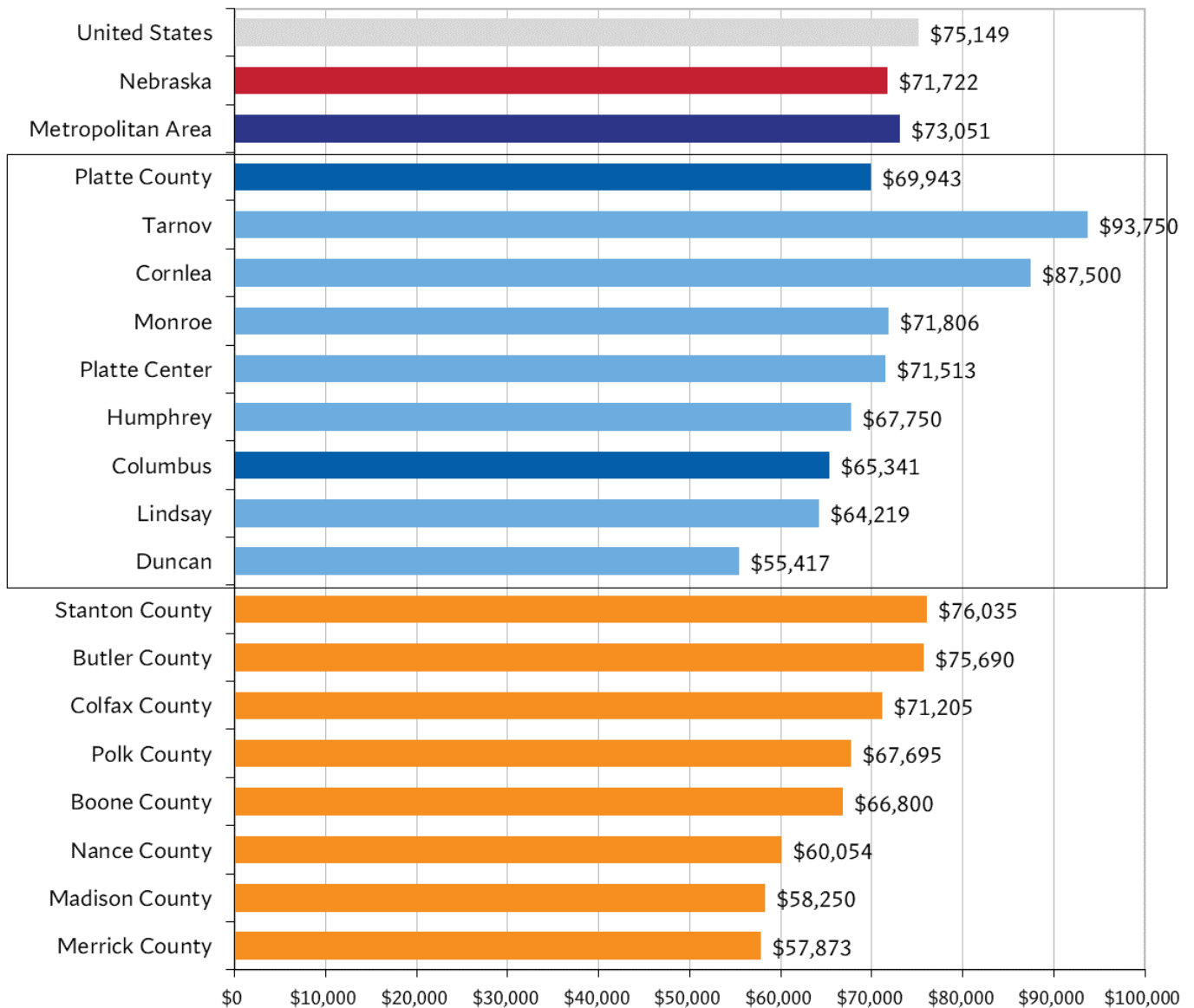
Median household income provides a different perspective of income levels than median family or per capita income. Family income is defined as having two or more related people in a household. Household income (used in this study) can consist of multiple family members or can be represented by a single person.

The 2018-2022 five-year estimates show median household income for Platte County is estimated to be \$69,943 compared to \$71,722 for Nebraska as a whole.
